QUALIFICATIONS FOR CLUB MEMBERSHIP

RIGHTS OF MEMBERS

(A)(i) Life members, Service members, Service Associates and Club members only of the Club shall have full voting rights and, subject to the constitution, be eligible to be elected to or hold office on the Board.

(ii) Social members, Staff Associates and Junior sporting members shall not be permitted to participate in the management of the Club nor to vote at any General Meeting of the Club.

(B) Each financial member who is eligible to vote shall have one vote.

(C) The rights of members to sue the sporting and other facilities of the Club shall be as the Board may determine from time to time by By-law or otherwise provided that Social members shall not be entitled to join social and sporting sections of the Club.
